Shade Tree Board Meeting

Members Present (6): Amy Banks, George Poe Jr, Ken Webb, Dale Hughes, Matt Coleman Will Jones.

Members absent (2): Dennis Epperson & Milan Blake.

Called Meeting to Order: Amy Banks called the meeting to order and welcomed everyone.

Special Guests: Casey Zipperer, Tracie Shellhouse, Delaney Walker and Lee Jones.

Waive Reading of Minutes:

Jo Benjamin made a motion to approve the January 26, 2016 meeting minutes with one correction (18,000 homes city wide).

Will Jones second the motion.

All in favor. None Opposed. Motion carries.

Amy welcomed everyone. We have guests from New Hope Pregnancy Center.

New Hope Pregnancy Center – Safety Concern Two Red Oak Trees

Casey Zipperer, Tracie Shellhouse, Delaney Walker and Lee Jones requested assistance with the acorn and leaf problem at the New Hope Pregnancy Center located at Worth/4th Street (old oncology building). There are two 20 year old red oak trees that constantly drop acorns. This is a safety concern because they have clients coming in and out and the acorns pose a slip/trip hazard. Last year, they had one client to fall that was on a knee skooter.

Dan Hartman stated that he had received 16 phone calls requesting to keep the trees. He asked about the condition of the tree. There are no dead limbs. The trees are healthy. They have tried to keep the sidewalks clean but do not have the staffing.

Amy Banks stated that she has seen these trees. They are uniform. They are in their prime. They bring value to the building.

Matt Coleman disclosed that his family has worked with New Hope for years.

After a lengthy discussion of the issues. Several suggestions were made by the board about sweeping/blowing the sidewalks... Installing a watch your step sign also suggested. Dan Hartman stated that will ask someone to look at Public Works to look at the cracked sidewalk. It's most likely caused by the roots of these 20 year old trees. Dan stated he can trim the trees (not cut) before the leaves come out. This may help control the drop age of the acorns and leaves especially when they are dropping the worst from September - November. His crew will perform the trimming on a Friday when the office is closed. Everyone seemed happy with this proposal.

Urban Forestry Report:

101 trees were planted

4 trees were trimmed.

Removed all leaves and debris from all pavilion gutters and roofs at Tinsley Park.

Installed eight new trash containers at Mouse Creek Soccer Fields and five at Greenway Park.

Repainted Deer Park, Fletcher Park, Greenway Trailhead restrooms.

Dan also attended and spoke at the Chattanooga Area Landscape Professional Association Conference.

A complete copy of his report can be seen in his hand-out.

Jo Benjamin stated that she would like to find more locations to plant trees.

OLD BUSINESS:

Orchard Grant News:

Dana Teasley did not attend the meeting. Amy Banks stated that we were not awarded the Orchard grant.



Topping Trees Destroys Beauty — and More

During this season when the beauty of trees and idyllic landscapes are part of our celebrations, topped trees remain a plague in many parts of the country. John Davey, founder of Davey Tree Experts, began a campaign more than 100 years ago to stop this destructive practice, yet it persists today, especially in rural areas and small communities.

Eight good reasons why topping a tree is a bad idea

- **Starvation.** Reducing too much of the crown reduces the tree's ability to produce the sugars it needs.
- Shock. The reduction of shade on other parts of the tree can have a negative effect.
- 3 Insects and Disease. The large stubs are vulnerable to rot and attractive to insects.
- Rapid regrowth. The prolific growth of resulting sprouts quickly restores size but with a less safe crown.
- **Second Second S**
- Tree death. Some species cannot tolerate topping and the result is decline and early death.
- Ugliness. A topped tree is a disfigured tree. It is a tree robbed of its natural shape and beauty.
- Cost. The savings in cost from quick topping by unskilled individuals is lost in the long run by the negative results of this malpractice.



The silhouettes of topped trees are a sure sign that someone did not get the message about the negative effects of this unfortunate treatment of landscape trees.
